5. Equipment failure.
6. My physical condition.
7. The possibility of being thrown from, stepped on, bitten by, kicked by animal or horse.
8. Variable weather and environmental conditions.

This assumption of risk includes the risk of injury or harm that may be caused by the negligent acts or omissions of third parties including, but not limited to, Kingsmen Inc. And its staff. In consideration and exchange for participating the Animal & Equine Activity, I voluntarily release and discharge Kingsmen Inc. from any and all liability, claims, demands or causes of action that are related to or arise from and are in any way connected with my participation in the Animal & Equine Activity.
